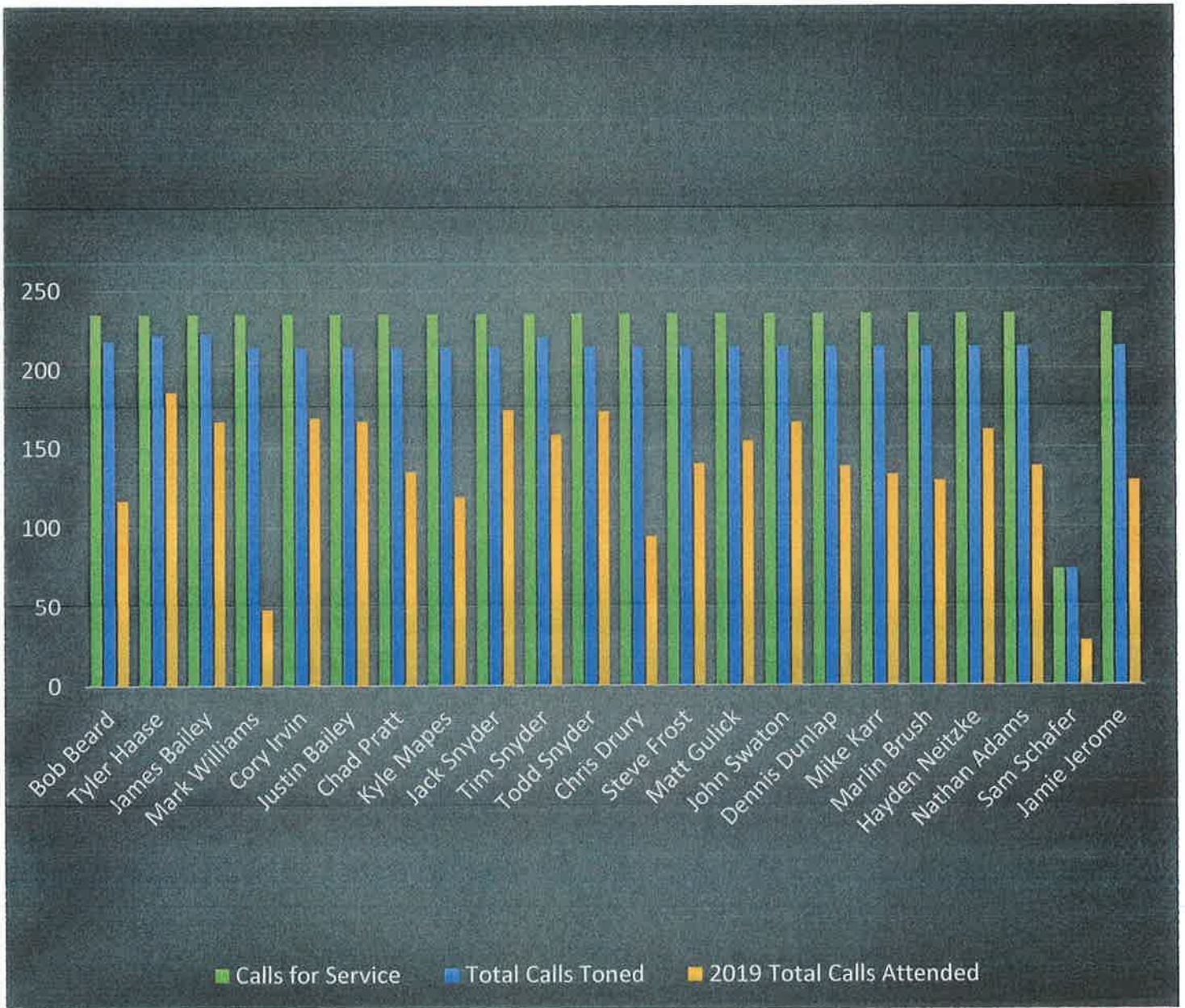


In 2019, the Alma Fire Department responded to 256 calls for service. The Alma firefighters were dispatched to 214 calls, 21 community service (parade duty, fire prevention, safety day ETC) and 22 training/meetings. There were 42 complaints, a call may be classified as a complaint if it is non-emergency and requires limited personnel, instead of the full department alarm required in an emergency incident. These are often investigations into issues such as improper burns, downed power lines, or suspicious smells. Complaints are usually handled by senior officers of the Alma District Fire Department.



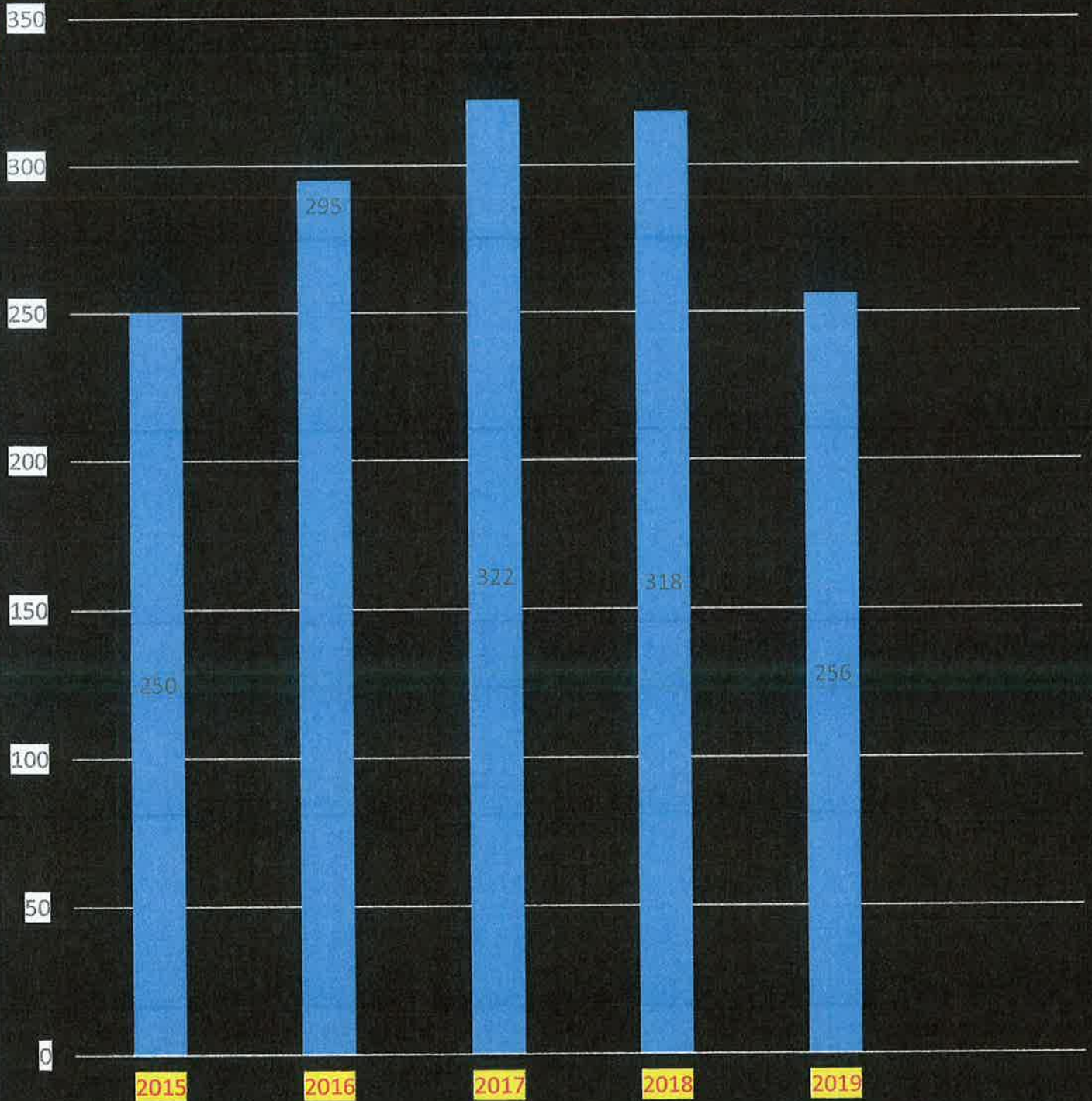

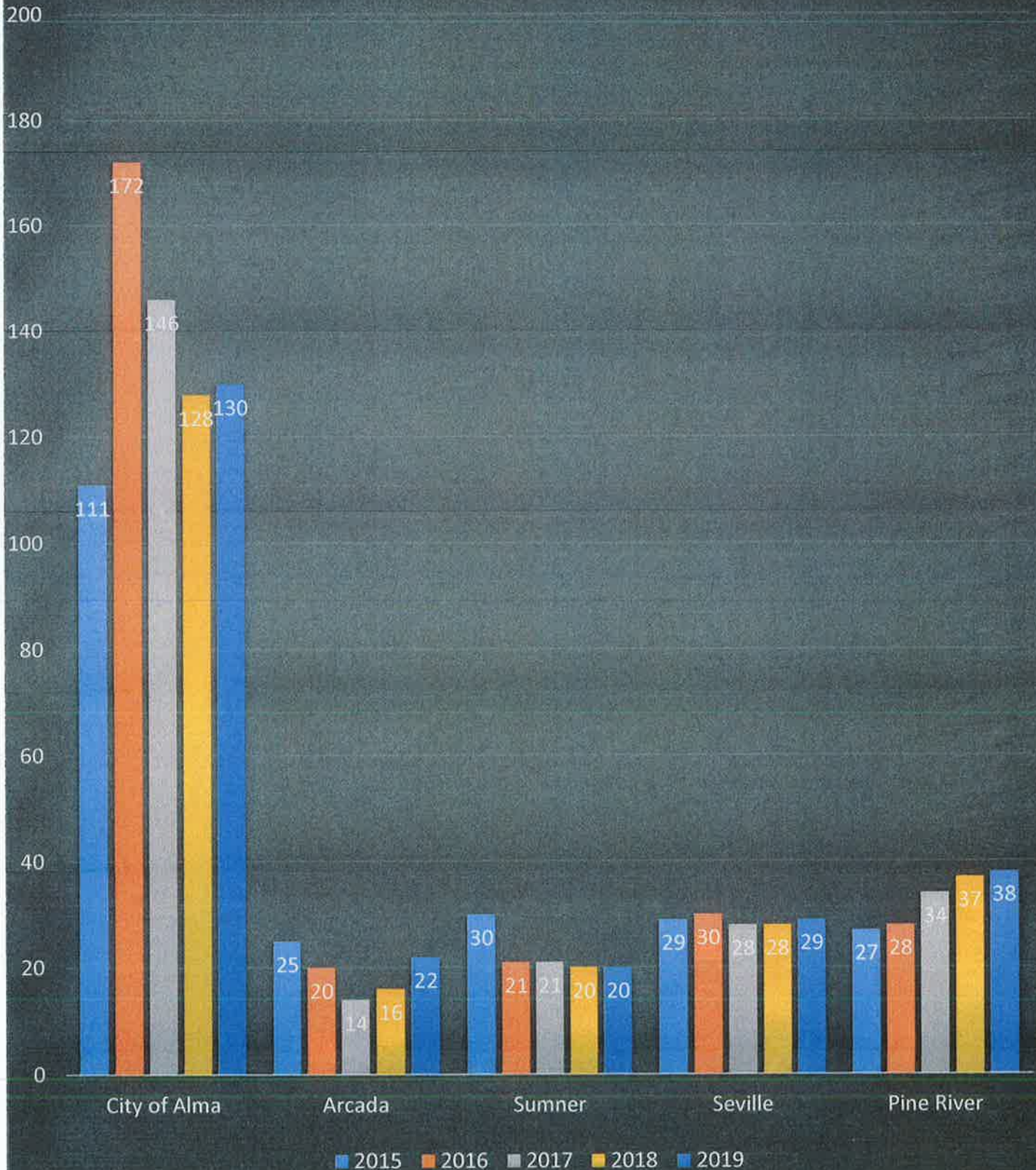


There were a total of 256 calls for service in 2019. Firefighters were toned for 214 calls, the other 42 calls were complaints and 21 community service (parade duty, fire prevention, safety day ETC). Complaints are usually handled by senior officers of the Alma District Fire Department. Firefighters are required to attend no less than 50 percent of calls each year. In 2019, the average percentage was well above 50 percent and the department is constantly working hard to provide the best service possible.

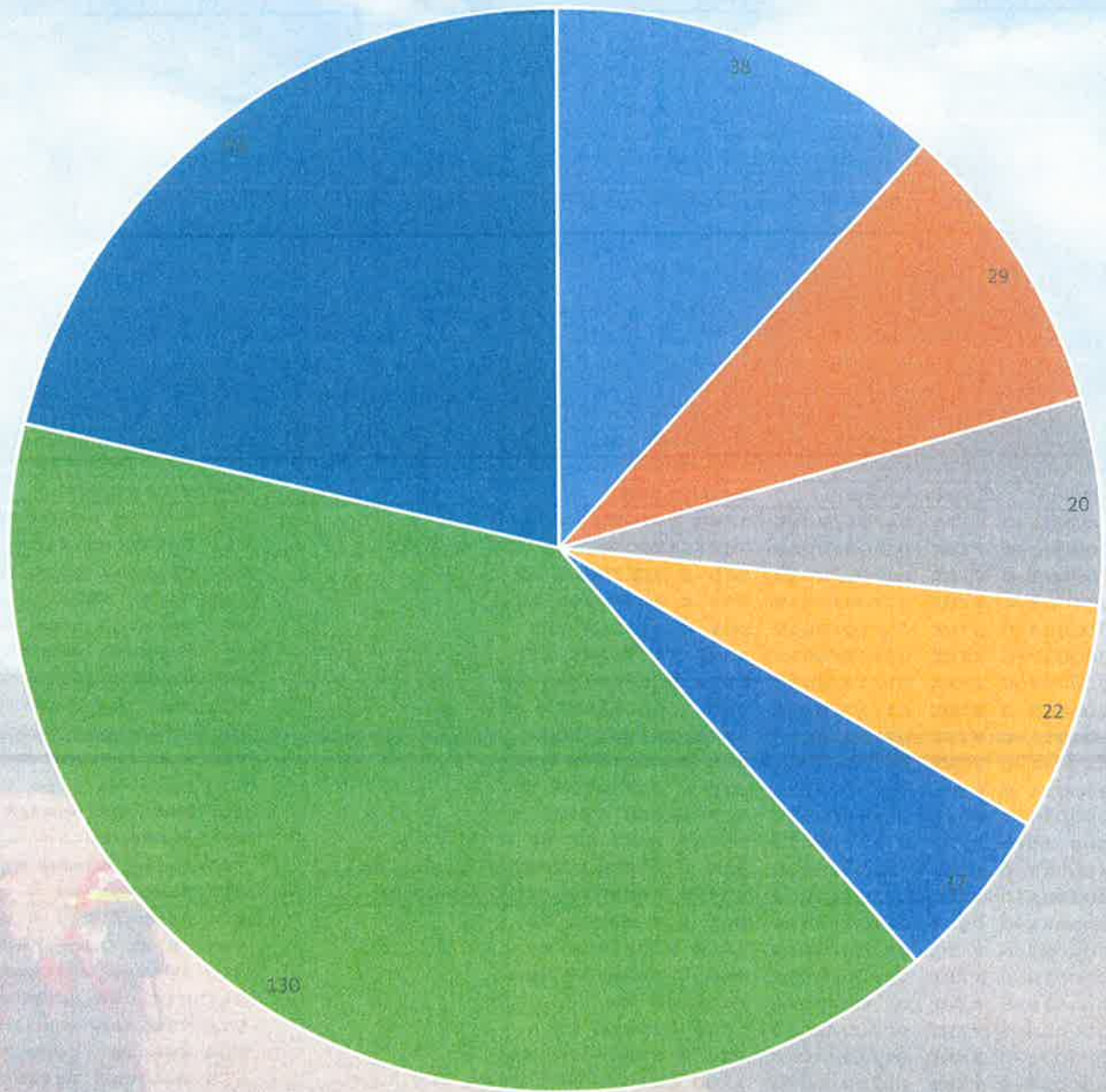


# Five Year Comparison: Local Unit Incident Totals
