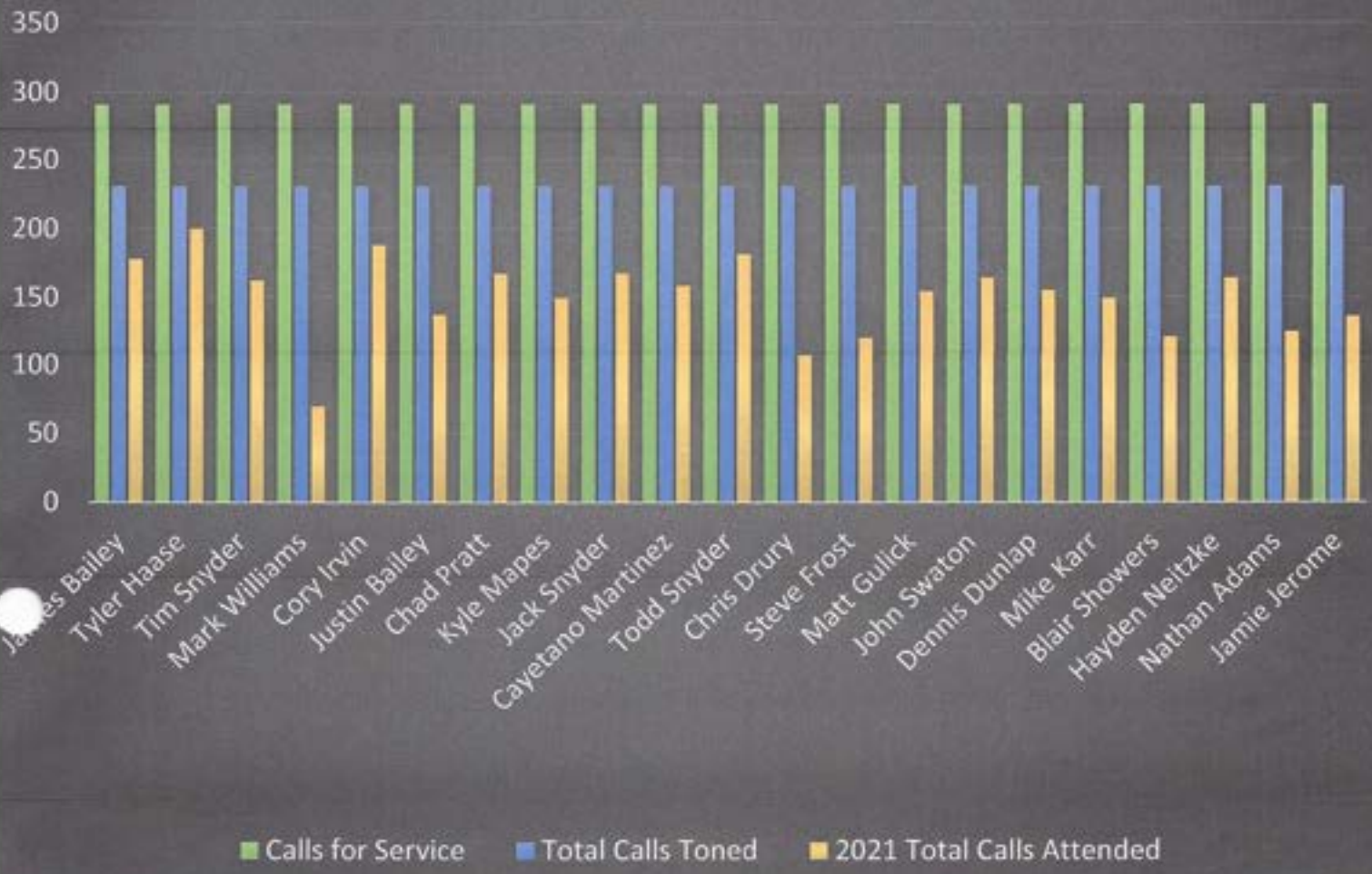

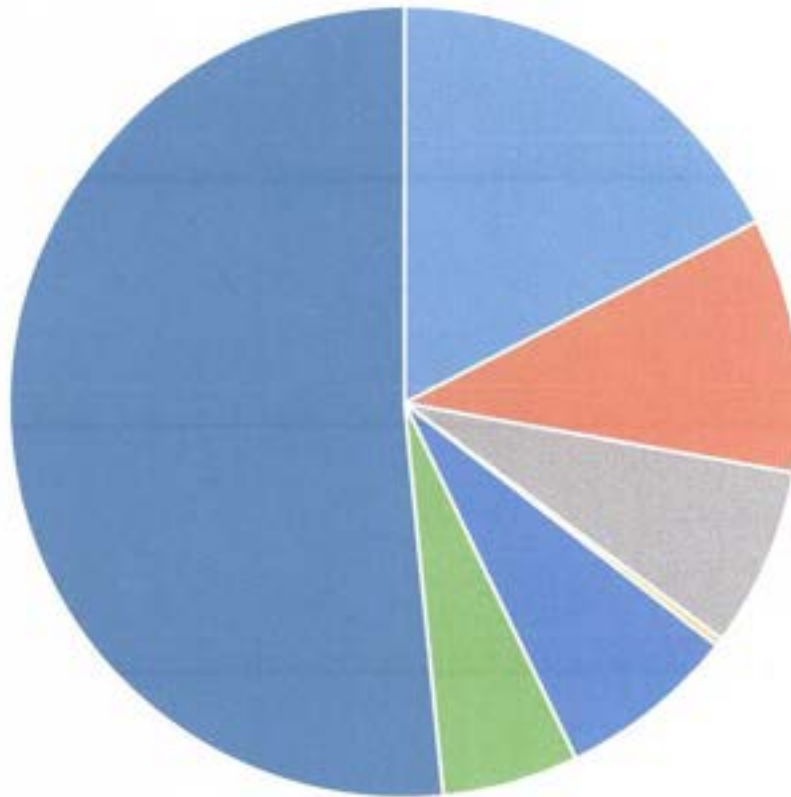

ADFD had a total of 291 calls for service in 2021. Firefighters were toned for 231 of those calls; the other 60 calls were complaints. Complaints are handled by officers of the Alma District Fire Department. Firefighters are required to attend no less than 50 percent of calls each year. For the year of 2021, the average percentage remains well above 50 percent at 65% and the department is constantly working hard to provide the best service possible.

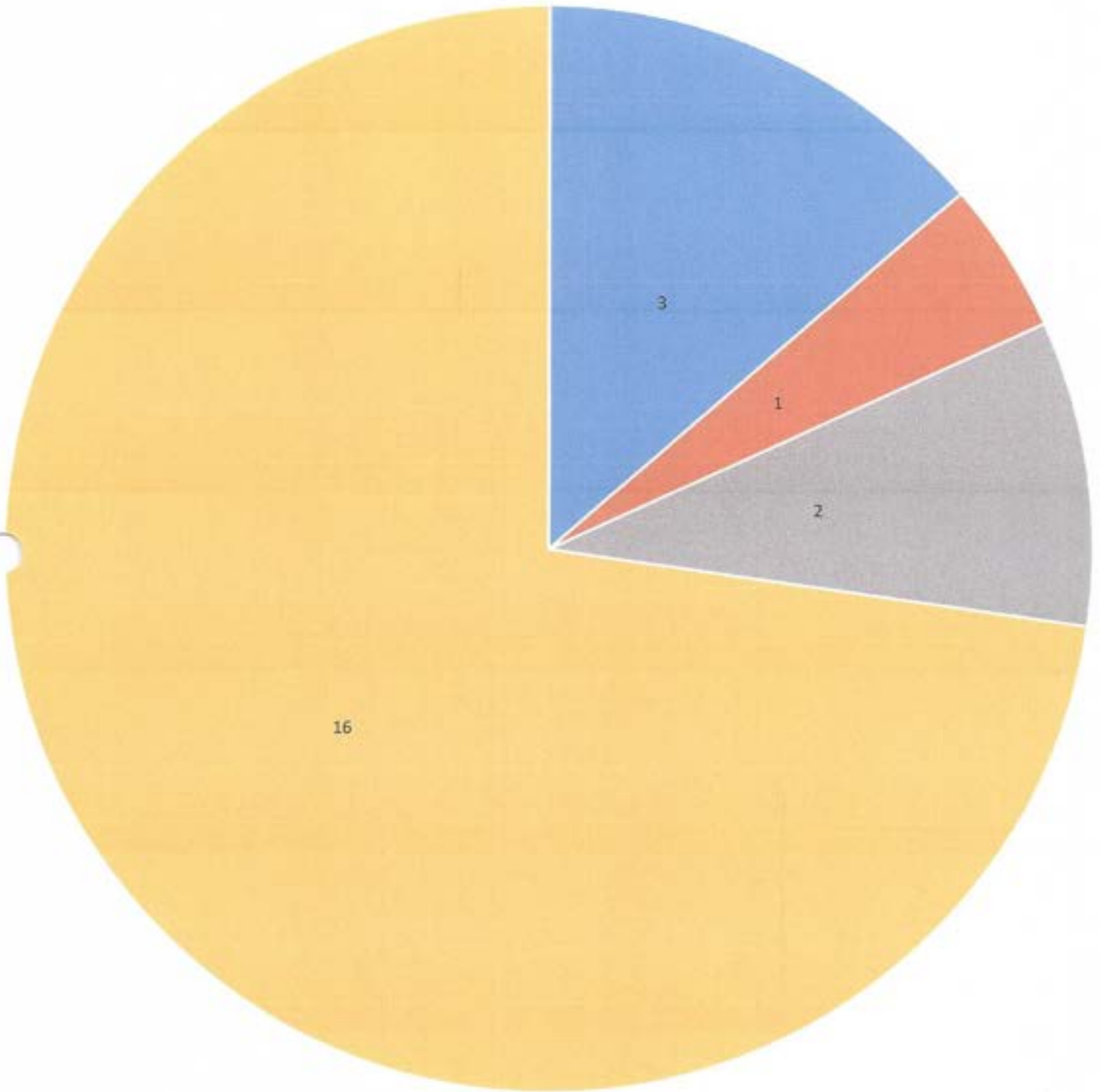
Districts Calls For service

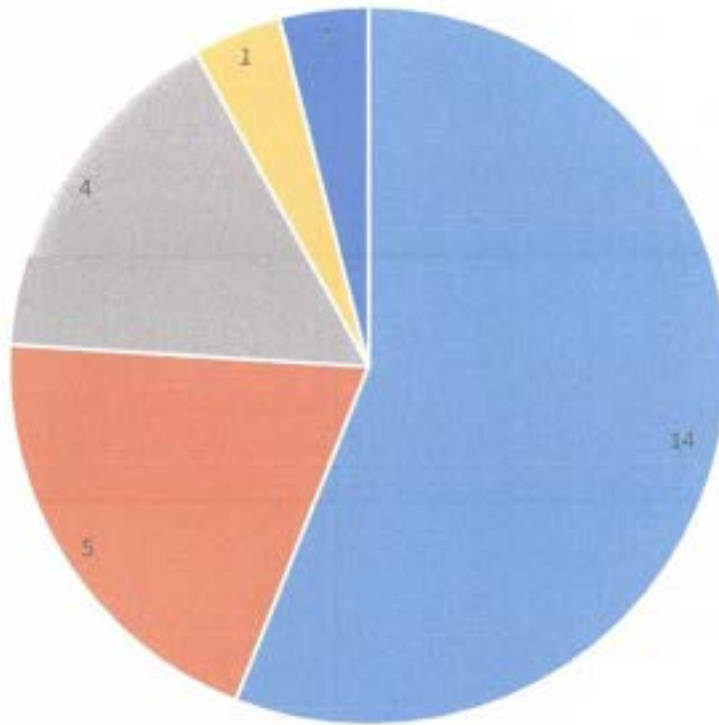


Calls For Mutual-aid

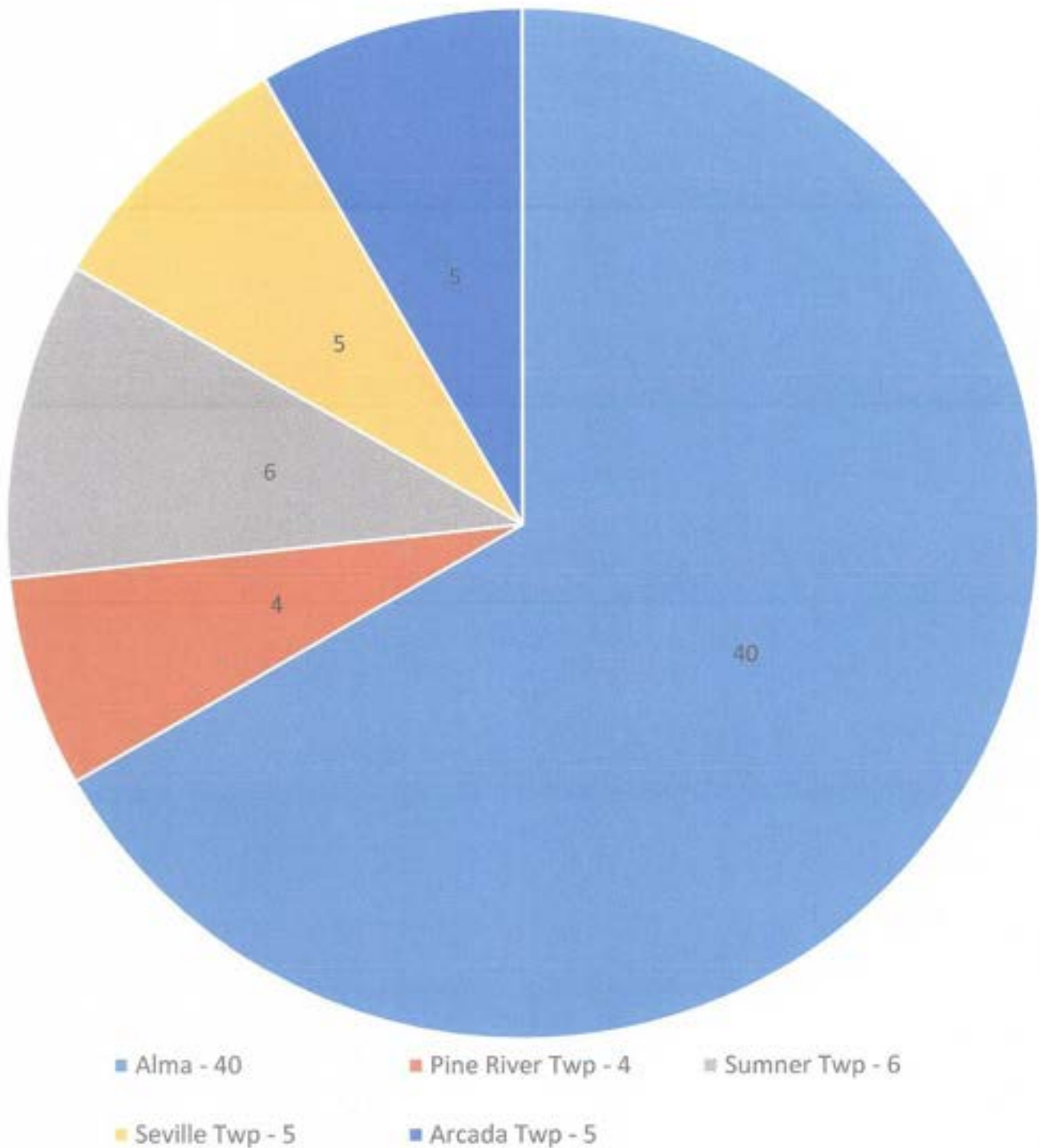
