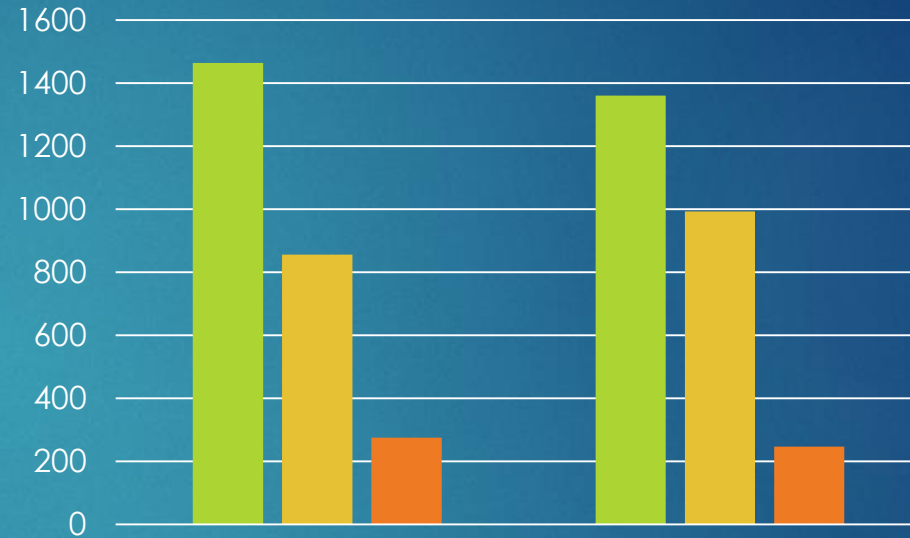

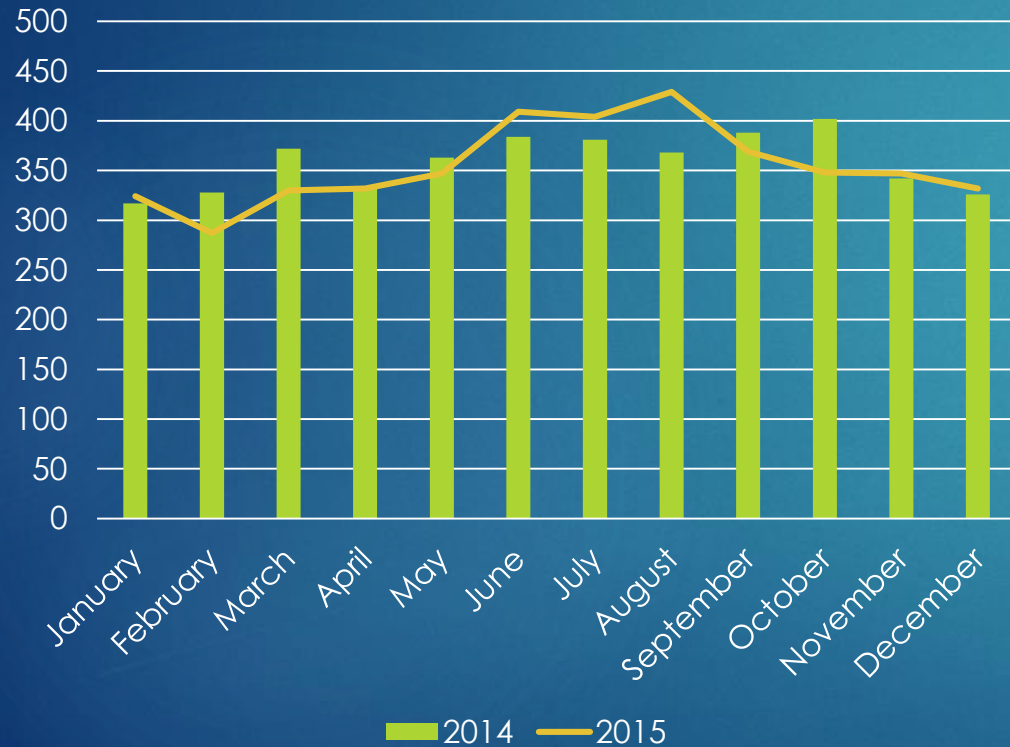

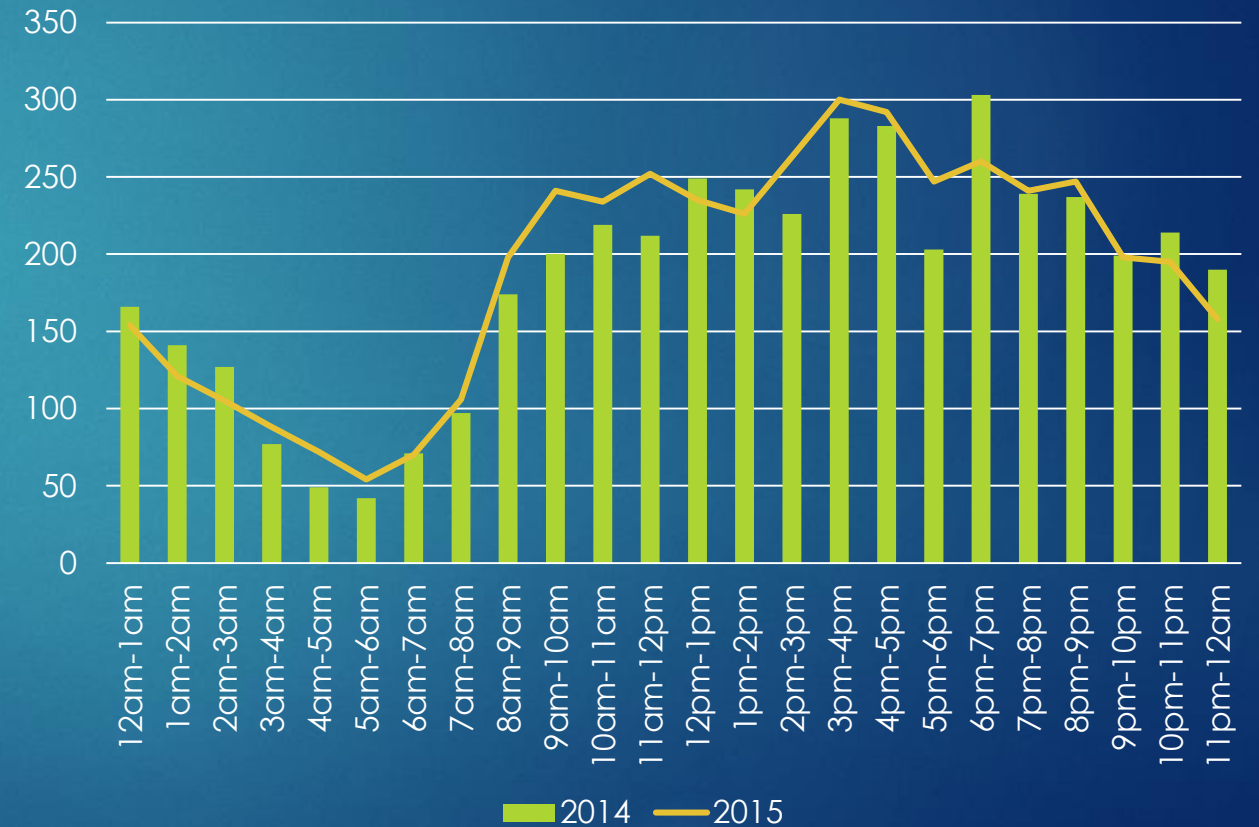

By Month



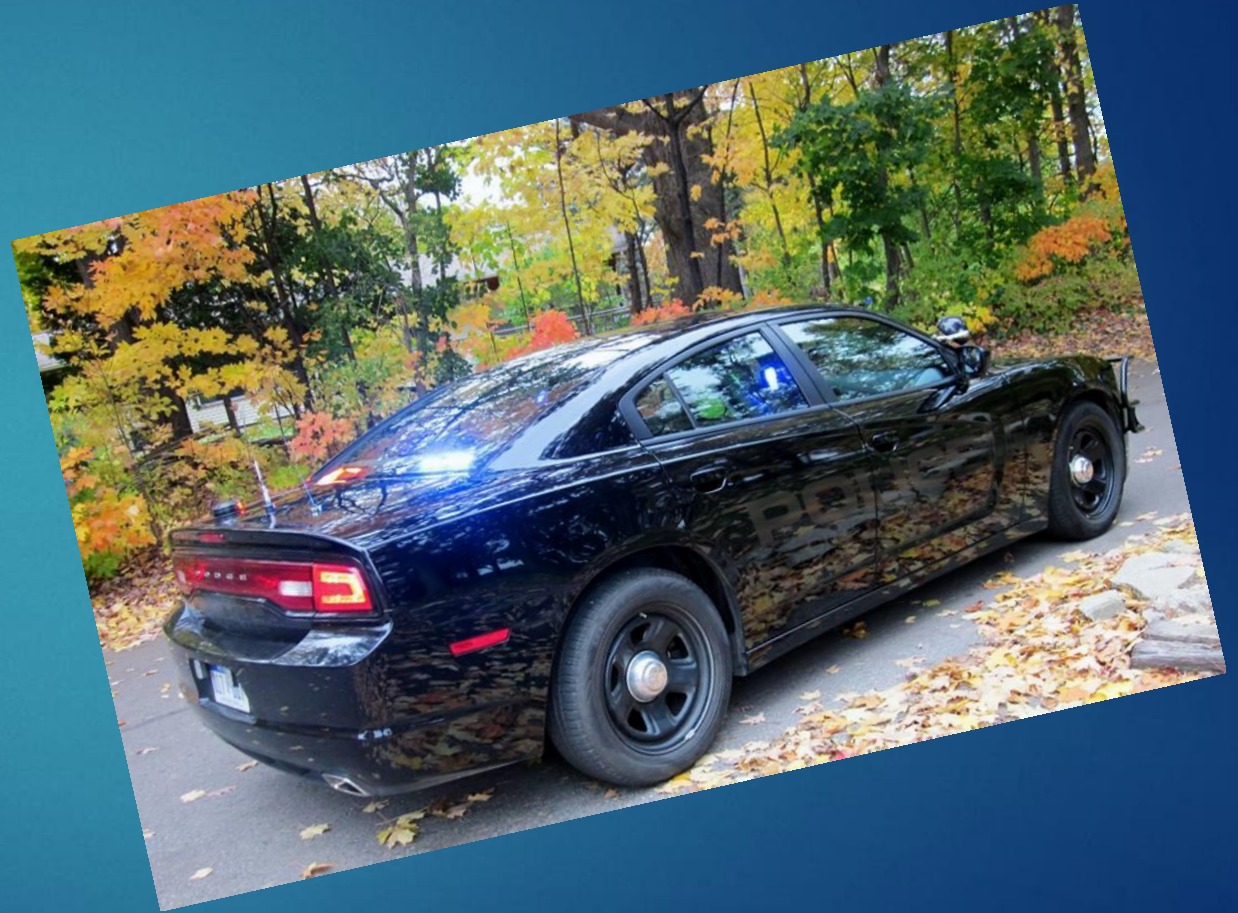
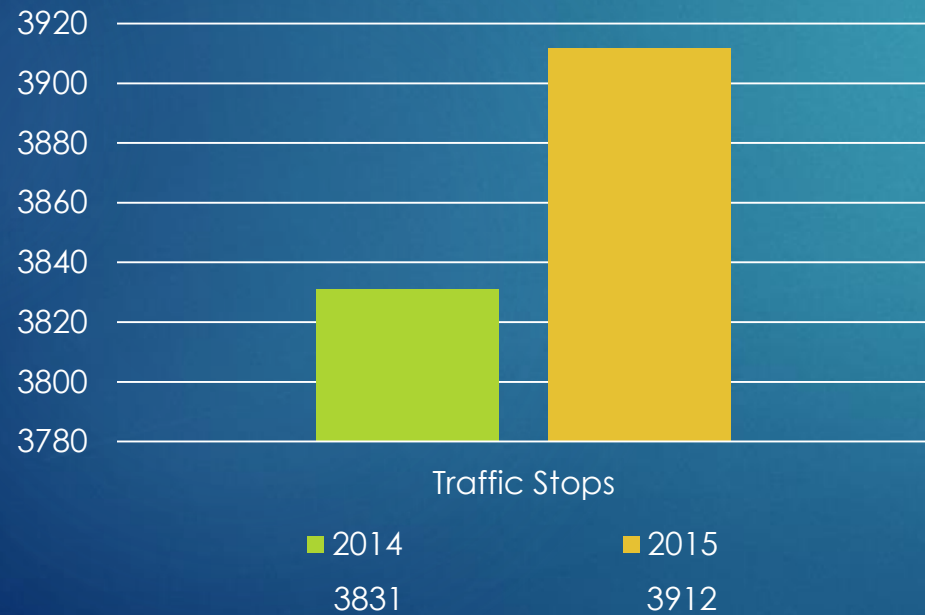
By time of day

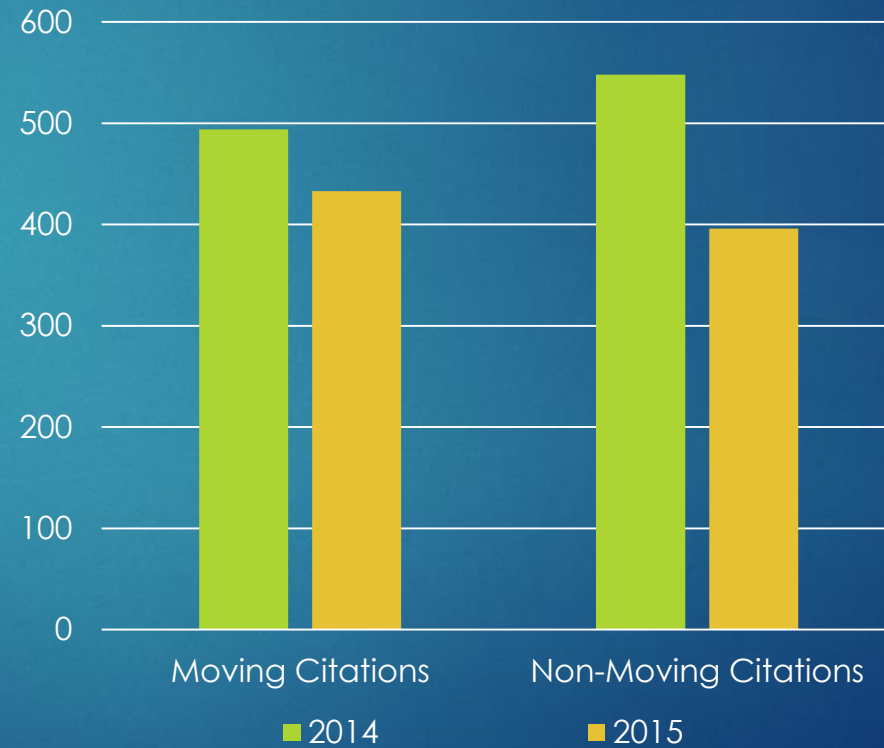

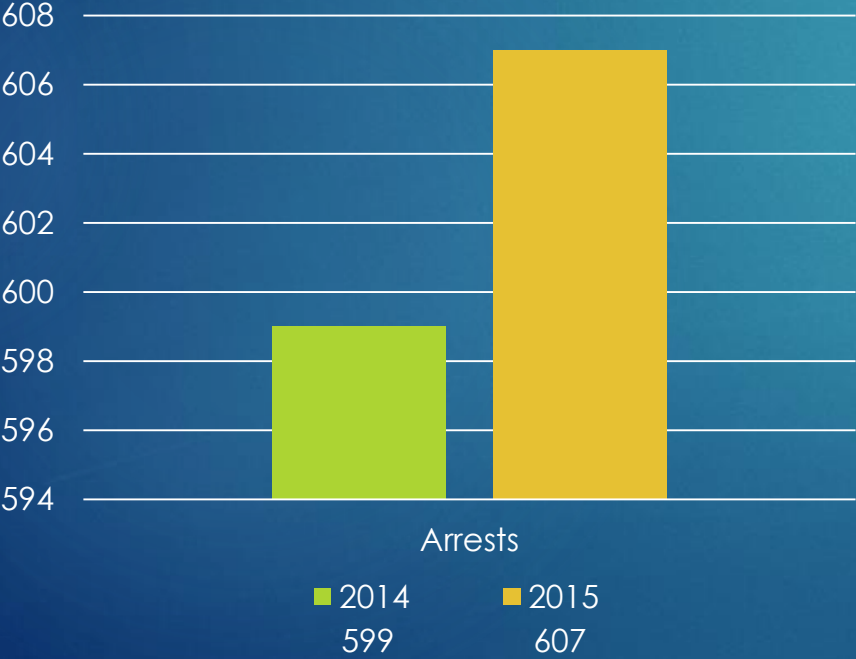

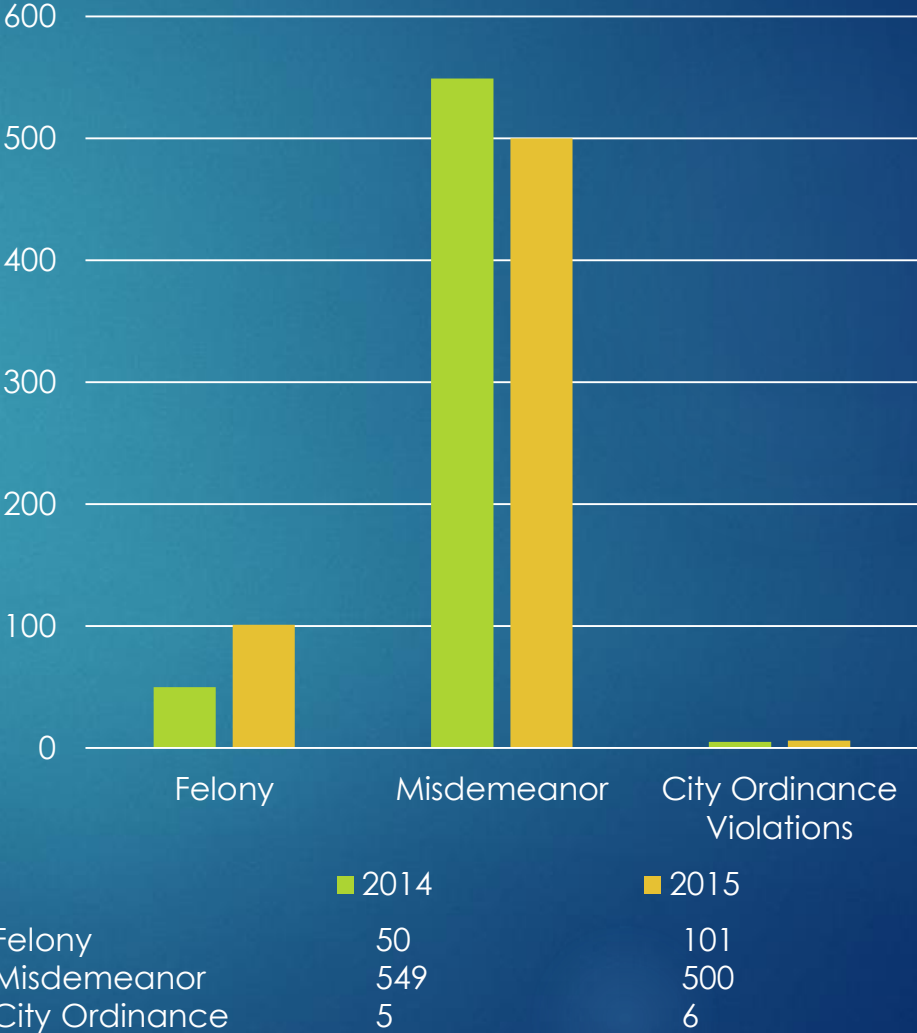
Total Arrests 2015...

Arrests at a glance...

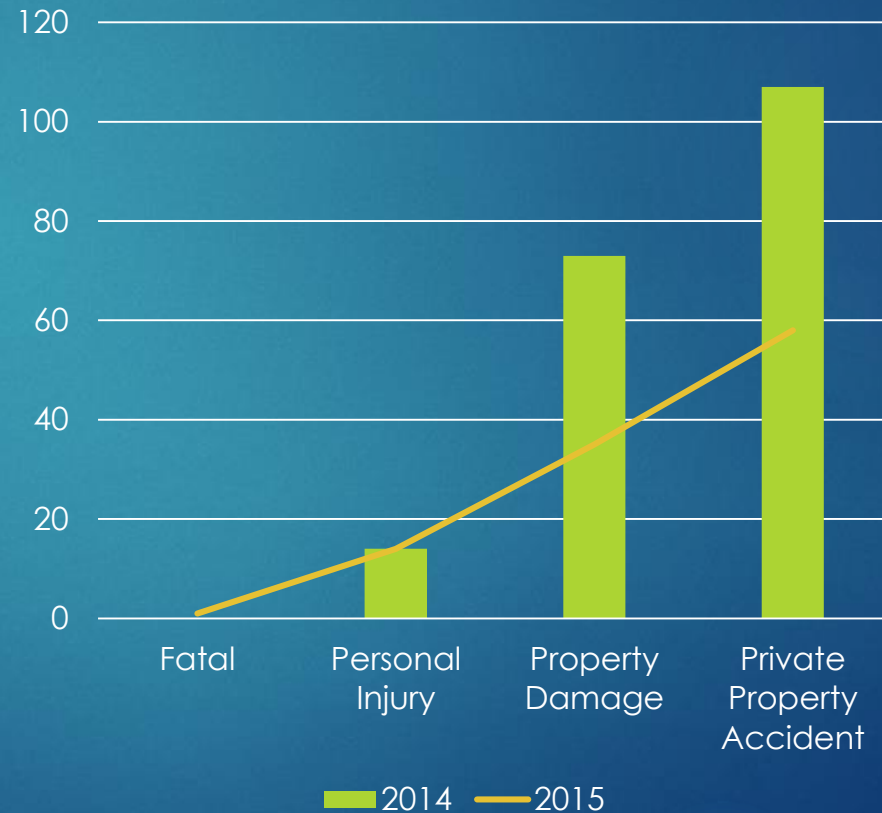

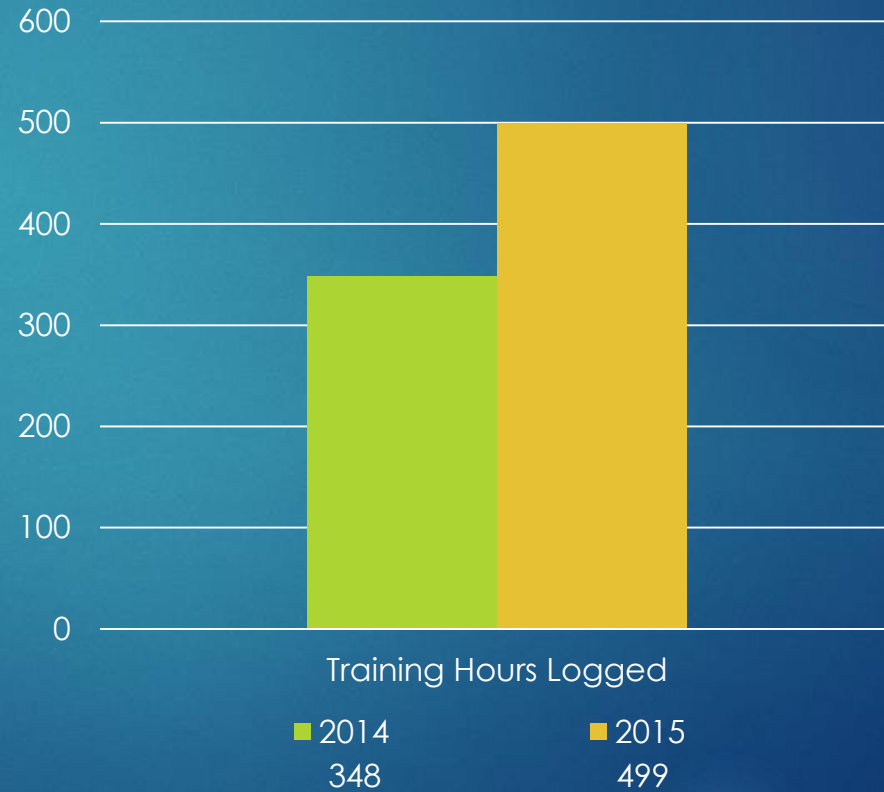
Yearly Comparison
