Chairman Giles reviewed the Water Production Report for September. No comments or suggestions were offered by Board Members.

Chairman Giles reviewed the Financial Statements through June 30, 2021 for the audit and the Financial Statements through September 30, 2021. No comments or suggestions were offered.

John Willemin of Fishbeck, Thompson, Carr & Huber, provided a written report on the St. Louis Water Supply Replacement Engineering Update. A brief discussion followed regarding the update. The Part 399 permit application has been submitted to EGLE and is awaiting approval for construction of the Well house and well water transmission main. An upcoming meeting with Arcada Township for presentation on the project needs to be scheduled. Dave Ringle, Director of Public Services, will work to schedule the presentation for Wednesday, November 10, 2021. GAWA has been granted an extension of time with the EPA cooperative agreement for funding the water supply replacement project. They are looking at monitoring groundwater in the Arcada Township area for at least another year, possibly long-term after the project is completed.
