

ORDINANCE #809

ORDINANCE TO AMEND THE ZONING MAP OF THE CITY OF ALMA AS IT APPEARS IN SECTION 32-32 OF THE ORDINANCES OF THE CITY OF ALMA

The City of Alma Ordains:

1. Section 1.

The Zoning Map of the City of Alma as it appears as Section 32-32 of the Ordinances of the City of Alma is hereby amended in the following respects:

The premises hereinafter described, currently zoned as B-1, Central Business District, be and hereby is conditionally rezoned to BMR, Business Multi-Family Zoning District, subject to the conditions set forth in the Conditional Rezoning Agreement entered into relative to the subject premises on this date. The premises are described as:

ELYTON. LOT 4 EXCEPT N 3 1/2 FT, BLOCK 3 (313 N State Street)

2. Separability. If any section, subsection, paragraph, sentence, clause, phrase or portion of this ordinance is, for any reason, held invalid or unconstitutional by any Court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions thereof.

3. Ordinances Repealed. All ordinances and/or parts or ordinances inconsistent with this ordinance are hereby repealed.

4. Effective Date. This ordinance shall take effect and be in force 15 days from and after its enactment as provided by the City Charter.
